The Merchant's House Museum is New York City's only family home preserved intact from the 19th century and Greenwich Village's only historic house museum. A rowhouse built in 1832, it is among the finest surviving examples of late-Federal and Greek Revival architecture of the period. Home to prosperous merchant Seabury Tredwell and family from 1835 to 1933, the landmark house, which has been a museum open to the public since 1936, reflects in its original textiles, furniture, and decorative arts the lifestyle of a typical New York City upper-middle-class family of the last century.

Hours: Sundays through Thursdays, 1 to 4 p.m. Group tours by appointment. Admission: Free for members, \$3 for the public.

## Celebrating 30 Years of the Landmarks Law

From "Lost, and Found, in New York," an editorial in *The New York Times*, March 30, 1995:

"Because of the law, New York City is far richer in monuments, grand and modest, to its colorful, convoluted history that it would otherwise be. New Yorkers are richer, too. We do not have to go to a movie to see where Edgar Allan Poe was treated for a minor medical problem, or how a 19th-century merchant lived, or the greatest collection of cast-iron buildings in the United States. All we have to do is walk the right streets."

That's 29 East Fourth Street, since 1832:

### The Road to Accreditation

Accreditation by the American
Association of Museums (AAM) is the goal
sought by most museums in the United
States. Accreditation demonstrates that the
museum and its collections are being
managed at the highest level of
professionalism. The Institute of Museum
Services (IMS), an independent agency
within the Executive Branch of the Federal
Government, has awarded several grants to
the Merchant's House aimed at improving a
wide range of museum activities, including
bringing the collections management and
administration of the Museum into
conformity with standards set by the AAM.

The Museum Assessment Program (MAP I) addressed long-range planning of programs and operations, helping the Museum structure its operations more effectively, improve service to the community, and increase its base of local support. Last year, the museum was awarded a MAP II grant from IMS to assess its collections. MAP II has assisted in developing priorities for care and management of the Museum's sizeable collection.

Most recently, through the Collection Assessment Program (CAP), the Museum has received funding for an independent conservator to assess the condition of the objects in the collection. The evaluation is planned for July. Once the CAP Assessment has been completed, the Museum will be in a position to make a Conservation Project Support request for the care, repair, and conservation of specific objects in the collection.

#### The Gift of Time

We would like to welcome -- and to extend our thanks to -- several new volunteers who have found their way to East Fourth Street. All the way from the Ukraine, Gregoryi and Irina Yalovskaya have brought good cheer and willing hands as they accomplish varied tasks. Gregoryi and Irina come to us through the New York Volunteer Referral Service.

Also new to the Museum is John Rommel, who has taken on the daunting task of overseeing the planting and maintenance of the Museum's garden. The wisteria is being tamed, new plantings are in the ground, and other greenery has been cut back to improve its growth.

Lilli Leill, who gave the garden a new lease on life last year, has now taken on management of the Museum's store, purchasing t-shirts, mugs and postcards, among other items. Lilli is also contributing her time as an intern from CUNY, working on the first consistent, accurate and readable genealogy of Seabury Tredwell and his forebears and descendants.

Special thanks go to Margaret Tamulonis, who sees that Sunday afternoons run smoothly; Sue Preston and Carol Kelly, who arrive with regularity to give tours; and Dea Dios who faithfully oversees the door ... to Betty Chaurize, Anthony Hadaway, and Jennifer Airo for help with mailings ... to Peter Vilsack for his holiday decorations of the House in December ... to Jerry Pivak for repairs and a promise to build shelving needed for the trunk collection ... and to Director's Council members Maryanne Botini, Katherine Jacobus, Missy Kostel, Ariane MacLean, Jennifer Orr, Ashley Perry, and Lauren Zarelli for their outstanding assistance at major events. Our thanks to these and to all of our volunteers whose invaluable gift of time makes it possible to run this historic site.

## Calling All Tredwells

This spring, we began a cross-country search for members of the Tredwell family -- direct descendants of Seabury and Eliza Tredwell as well as descendants of other lines of the extended Tredwell clan. Mrs. Ruth Stebbins Cadwell, who lives in Pennsylvania, is a great granddaughter of Seabury and Eliza and has been closely involved with the Museum for many years. Recently, she has seen to it that objects

removed from the house by relatives in the 1930s, after the death of Gertrude Tredwell, are being returned to the house. Mrs. Cadwell has kindly agreed to help us in our search.

We would like to hold an annual "Tredwell Event" at the Museum and perhaps publish a newsletter. A number of Tredwells have already been found -- in Connecticut, Indiana, Michigan, Maryland, Montana, Pennsylvania, Florida, Wisconsin, Massachusetts, Washington, and New Jersey, in addition to a number in New York State. If you are a Tredwell -- or if you know anyone who is -- please let us know.

## Garden Paving Project To Be Completed

Many first-time visitors to the Museum are pleasantly surprised to find that after touring three floors of period rooms with original furnishings, art and objects, they are invited to enjoy our traditional 19th-century walled garden as well. Few representative examples have survived intact, and even fewer are open for public inspection and enjoyment.

This month, we will undertake a project to fill in the two center parterres with granite, which will not only make the garden more attractive but will increase the usable space for museum events. Improvement of the garden is a project that we have wanted to complete for years. A number of generous individuals have enabled us to undertake it now (and just in time for Midsummer Night's Revelry on June 21!). We are enormously grateful to Neill Parker, A.I.A., for his terrific design. Thank you, again, to Board member Kate Ottavino and to her father, George Ottavino, of the A. Ottavino CVI Granite company, who generously contributed the granite.

IRT: Lexington Avenue local #6 to Astor Place. Walk South on Lafayette Street to 4th Street and walk 1/2 block East. BMT: Local R or N to8th Street. Walk South on Broadway to East 4th Street and walk 1 1/2 blocks East. IND: D or F to Broadway/ Lafayette. Walk North on Lafayette for 3 blocks, then East 1/2 block.

By Bus:

Bus #M5 or M6 to Broadway and 4th Street. Walk East 1 1/2 blocks; Lexington-Third Avenue Bus #M102 to East 4th Street, walk West 1/2 block; Bus #M1 to Boradway and 8th Street, walk South on Broadway to East 4th Street and 1 1/2 blocks East.




