Astor Challenge Grant Appeal Goes Over The Top \$1,650,000 Endowment Secures Museum's Future

I admit it—I counted the zeroes. After all, it isn't every day that a messenger delivers a check for \$1 million. But that's what happened here at the Merchant's House one very happy day last December.

The December 15 deadline for The Vincent Astor Foundation's Challenge Grant had been reached, and at the final tally, we had raised \$650,000—far exceeding the \$500,000 required by the terms of the grant. The \$1 million was ours. Now, for the first time since the Museum opened in 1936, an Endowment Fund is in place—assuring the survival of this irreplaceable 19th-century landmark for future generations.

We are grateful beyond measure to the Astor Foundation and to the 627 friends who responded to our appeals. A significant portion of the Museum's annual operating budget for collections care, educational programs, and restoration will now be provided through income generated by the Endowment Fund.

I personally want to thank all of you who rose to the occasion to help us reach our goal. Owing in large part to you, the Merchant's House will enlighten, educate, and inspire into the 21st century and beyond.

The Merchant's House is New York City's only family home preserved intact from the 19th-century and Greenwich Village's only historic house museum. A rowhouse built in 1832, it is among the finest surviving examples of late-Federal and Greek Revival architecture of the period. Home to prosperous merchant Seabury Tredwell and family from 1835 to 1933, the landmark house, which has been a museum open to the public since 1936, reflects in its original textiles, furniture, and decorative arts the lifestyle of the family of a 19th century New York City merchant prince.


